Sir,

Reference is invited to your letter no. MPL; MoE&F:2007:5:2878 dated 18.05.2007 regarding environmental clearance for expansion from 1000 MW to 1050 MW and change in configuration from 4x250 MW to 2x525 MW in respect of the above mentioned project.

- 2. It is noted that the environmental clearance for the 4x250 MW power project was accorded vide this Ministry's letter of even no. dated 22nd June, 2004. MPL has now proposed to install power project of 1050 MW (2x525 MW) instead of 1000 MW(4x250 MW) due to better heat efficiency and would provide advantage from environmental angle over the earlier configuration. It is further noted that:-
 - (i) No additional land is required due to the proposed expansion and change in configuration.
 - (ii) Water requirement will decrease from 4800 m3/hr to 4688 m3/hr.
 - (iii) The ash generation will be 1.56 million TPA in place of 1.77 million TPA.

- (iv) The maximum incremental ground level concentration of SO2, NOx and SPM will be 18.87 ug/m³, 11.02 ug/m³ and 1.78 ug/m³ respectively.
- (v) A bi-flue stack of 275 m height will be provided
- Keeping in view the above, the Ministry of Environment & Forests has no objection for expansion from 1000 MW to 1050 MW through change in configuration from 4x250 MW to 2x525 MW subject to strict implementation of all the conditions contained in the environment clearance letter of even no. dated 22nd June, 2004.
