1. INTRODUCTION:

Maithon Power Limited (MPL) is a 74:26 joint venture of The Tata Power Company Limited and DVC (Damodar Valley Corporation). MPL owns and operates 2x525 MW capacity, Indian coal based thermal power generation plant based on pulverized coal-based boiler technology. The generating plant is in Maithon near the city of Dhanbad in the state of Jharkhand in India. A brief overview of Owner and Site is given below:

2. Scope of supply of the Material:

This Procurement is intended for Coal Mill Roller Journal Assembly with journal head and 360 degree liner

Note:

- 1. One EA of intended Material meant to be one complete assembled set of Journal Assembly along with journal head & 360 Degree Liner.
- 2. Journal assembly to be supplied in ready to fit condition i.e. Only we will fit the Grinding roll and install it into the coal mill.
- 3. Lower & upper bearing of journal assembly must be of TIMKEN/SKF Make otherwise it will be technically rejected by us.

- 4. Vendor has to provide detailed assembly report of each assembly (Including Material test certificate & NDT if any) along with all dimensions and lift set etc. during the supply of material.
- 5. Journal assembly to be delivered by vendor in assembled condition along with all its bushes, packings, shim sets, oil seals, lock nut & check nut as required.
- 6. Vendor has to provide the part list to be supplied along with technical offer on enquiry.
- 7. Vendor Has to provide one to one Interchangeability certificate for all the items.
- 8. Vendor must provide fitment guaranty certificate for intended material with our existing installation.

In case of any deviation or fitment issue vendor has to take back the material and must supply the bearings of exact specified nomenclature.

Following shall be the pre-qualification requirement (PQR) for the supply of boiler tube. Bidders who meet all the following PQR's shall only be considered for Price bid evaluation.

TECHNICAL CRITERIA:

- 1. The Bidder must be an OEM supplier for intended material or must have the drawing of said journal assemblies for Coal Mill journal assemblies, Model-XRP-1003 and supply the same material to Tata Power earlier.
- 2. The bidder should have successfully manufactured and supplied as a prime contractor at least two numbers purchase order for Coal Mill Journal Assemblies of (XRP-1003) or Similar or journal assembly major components to any State government /Central government /PSU /Limited company.
- 3. The bidder should have a minimum purchase order value of 30 lakhs in a single PO for supply of Journal assembly or its components to any State government /Central government /PSU /Limited company.
- 4. The bidder must have complete setup for manufacturing of Coal Mill Journal Assemblies of his own.
 - 5. The Bidder must submit the drawing of Coal Mill Journal Assemblies (XRP-1003) during submission of bid.

FINANCIAL CRITERIA:

- 1. The average annual turnover of the bidder shall not be less than Rs. 1.0 Crores (Rupees one crores only) for the preceding three financial years (2021-22, 2022-23, 2023-24).
- 2. The financial net worth of the bidder shall be positive as per the latest audited annual report.

DOCUMENTS REQUIRED WITH BID FOR TECHNICAL/FINANCIAL CRITERIA

The bidder shall in his own interest, furnish complete documentary evidence to justify that he meets the 'Bidder Qualification Criteria' as given above. The bidder shall submit the following documents also along with the tender.

3. TENDER FEE & TIMELINES:

- **4. BID SECURITY:** (to be submitted along with RFQ and not with EOI)

Interested parties to note that Bidder is required to furnish a Bid Security along with their Bid (only during Bid Submission stage), as a Bank Guarantee (in the format prescribed in Bid Document) or as NEFT/RTGS/DD for an amount of INR 130,000/- (Indian Rupees One Lac Thirty Thousand Only). Bids not accompanied by an acceptable Bid Security shall be rejected by the Owner as being non-responsive and returned to the bidder without being opened.

Bidder shall be required to fulfill the following conditions and submit relevant supporting documents for each of the following criteria along with the Bid.

5. BIDDING PROCESS:

Detailed Bid Document (also referred as RFQ) shall be issued through Tata Power e-tender portal (Ariba System) only to the parties that submitted a valid EOI as per terms mentioned in this document.
